**Important:** PenCycle can only recycle **pre-filled Novo Nordisk** pens. Please only share details of the initiative with people who **already** use these pens. People who do not must not be encouraged to ask for a Novo Nordisk medicine or device.

**PenCycle** will not only reduce waste, it will also support the transition of the UK healthcare sector to achieve the **NHS' critical environmental targets**. The initiative will use existing logistics routes to minimise environmental impact.
